**Instructor of Record Biography:** Tanni Anthony earned a Ph.D. from the University of Denver in 2002 in the area of Child and Family Studies and Interdisciplinary Leadership. She has thirty-five plus years of experience in her teaching profession. She is currently the Director of the Access, Learning, and Literacy Team with the Colorado Department of Education's Exceptional Student Leadership Unit and serves as Project Director of the Colorado Services for Children and Youth with Combined Vision and Hearing Loss Project and as State Consultant on Blindness / Visual Impairment. Key responsibilities include:

- 1. Delineate the purpose of the course.

- 3. Identify the key presenters for the training session.
- 4. Develop and submit course proposal to UNC.
- 5. Contact school districts with course advertisement.

- 13. Assign grades.

**Course Description:** This two day course will cover key communication and tactile strategies for orientation and mobility instruction of individuals who are DeafBlind. Topics covered and for choosing from to use as appropriate for each unique individual include rapport and building trust, sign language considerations, basic tactile language/communication for discussions and providing quick information while on the move, available accessible telecommunication and smartphone apps and strategies for soliciting information and assistance from people in their community, why and when to use adaptive mobility devices (AMDs). Case studies, stories and videos will be shared; participants will engage in activities on both days of this training.

## **Course Presenters:**

**Carolina Gonzalez, COMS** graduated with a bachelor's degree in special education with emphasis in visual disorders from the University of Chile, Santiago in 1979. She graduated with a master's degree In Peripatology from Boston College, Boston Massachusetts in 1981. She has worked part-time as Certified Orientation and Mobility Specialist (COMS) at the Texas School for the Blind and Visually Impaired since 1990. She has worked part-time as COMS at the Texas School for the Deaf since 2007. Ms. Gonzalez has a special interest in working with students who are DeafBlind and their families.

**Heather Withrow, COMS** is a mother of three teenagers, one of whom is DeafBlind, one of whom is Deaf, and one of whom is a child of a Deaf adult (CODA). She received a Bachelor of Arts in graphic design from Gallaudet University, a Master of Education in Special Education with a concentration in Orientation and Mobility as well as a graduate certificate in Deafblindness from Texas Tech University. Heather joined the Texas Deafblind Project in August 2023 as a transition consultant and continues to provide O&M services to DeafBlind students at Texas School for the Blind and Visually Impaired. In addition to serving as a mother and an advocate for Deaf and DeafBlind Texans, she is a member of the Texas School for the Deaf (TSD) Governing Board and American Society for Deaf Children (ASDC) Board.

**Course Goals/Objectives:** Following this course, participants will:

1. Be able to describe various strategies to teach basic and advanced O&M skills when working with students who are DeafBlind.

- 2. Understand and practice basic ASL (American sign language) signs and some protactile to use during O&M lessons with students who are DeafBlind.
- 3. Participants will learn the benefits of and when to use an adaptive mobility device to help bridge the gap between basic skills and the use of a long cane for students who may need it.
