Course Description/Purpose

A non-technical course on the enjoyment and appreciation of music for students with little or no background. Course will be devoted to listening and discussion of assigned listening.

Learning Objectives

- Students will learn what “active listening” means and be able to apply it to a variety of music genres
- Students will be familiar with the eras of Western music along with major composers and pieces from each
- Students will be able to discuss music of various genres using proper music terms
- Students will attend live music events in their area

Supplies Needed for Class

Access to a word processor such as Word or Google Docs, internet connection and access to Canvas.

Attendance Policy

As this is a hybrid course, attendance will not be recorded. Assessment/Assignments

Weekly Discussions

Each week (excluding exam weeks), students will post an initial discussion post in response to the weekly reading and listening as well as comment on at least two (2) classmates' posts. Initial posts must be posted by Friday at 11:59 p.m.; Response posts must be posted by Sunday at 11:59 p.m.

Concert Report

Once during the semester, students must attend a live performance and complete a two-page concert report. A template will be provided.

Unit Exams

There will be three essay-style unit tests throughout the semester.

Final Exam

The Final Exam will be a comprehensive "tell-me-what-you-know" essay exam.
