Course Description:

This course provides an overview of human growth and development from conception through senescence and focuses on cognitive, affective, social, and psychomotor development.

Course Overview:

I am excited to share my enthusiasm about human development! This course is designed to develop your knowledge of various key developmental theories, explore critical research findings pertaining to development, and build your awareness of developmental needs and capabilities in various domains (e.g., cognitive, affective, social, physical, motor). This course will also focus on the influences of nature and nurture, as well as the important dynamic interaction between both nature and nurture on development as highlighted by the epigenetic theory of development. Distinctions between the various periods of the lifespan will also be thoughtfully explored.

Successful development can be described as “the relative maximization of gains and the minimization of losses” (Baltes, 1997, p. 367).

Class Format:

This course is fully online. The format of instruction includes:

- pre-recorded powerpoint-supported lectures on video,
- published video clips depicting key developmental milestones or findings,
- class discussion board, and
- various assignments to illustrate, discuss, and challenge your thinking about the relationships between theory, research, and clinical/school-based work that effect development.

Keep in mind, the recorded lectures will supplement and expand upon the readings and will not simply repeat it. My hope is to make this online course stimulating and personable as much as possible as we explore a variety of developmental psychology topics to ignite critical thinking and discussion.

Self-analysis is an important component in building our understanding of ourselves, and therefore important to counseling. This is a course that will involve self-introspection, self-examination, and

some degree of sharing personal information with the class. Therefore, students must be sensitive to the right to privacy of other students. It is important to be discreet and appropriate in your personal sharing during the course. Also, be very mindful of what personal information you post onto *Canvas*. It is important to self-disclose about yourself; but also, to be very mindful of what you share in class and not to share those personal things that you might regret sharing at some later point. Further, you must be sensitive to the privacy of your fellow students, and that all information shared during the course should remain CONFIDENTIAL.

- 1) Complete the readings prior to watching the video lectures;
- 2) Thoughtfully participate in the course (i.e., during your readings and reflection assignments by actively integrating new information into your repertoire of knowledge and considering various theories and research findings highlighted during the course);

- 4) Submit all assignments by the designated due dates.

Evaluation:

1) Quizzes will be completed each week on Canvas. Each of the 8 quizzes will be available at the beginning of each week and due prior to the module closing. The quizzes are not timed and you will

have 2 opportunities to complete the quiz. Plan to carefully review the feedback following your first quiz submission; the highest score will be recorded in the gradebook. The quiz questions are designed to be helpful in checking your understanding of key concepts referenced in weekly textbook readings and recorded lectures. The quizzes are mostly comprised of multiple-choice questions.

2) A series of 7 reflection assignments will be completed on Canvas (one reflection assignment for each module except for the last module will not have a reflection assignment). Assignment prompts and/or questions will be posted when the module opens and due prior to the module closing at the end of the week. Be sure to carefully review the guidelines for each of these assignments in order to ensure that all requirements are met. For example, many assignments will require written commentary to peers in addition to posting your own insights. Ultimately, these assignments are designed to ignite your critical thinking and analytical skills pertaining to developmental psychology based on text material, case studies, short readings, videoclips, peer-reviewed research articles, and recorded lectures.

3) A developmental autobiography paper is due on January 20th by 11:59 pm. Please post your paper to Canvas. Your developmental autobiography paper should be double spaced, have 12-point font, and 1-inch margins. The 4-5 page paper will be assessed based on thoughtful inclusion of the required points in the assignment guidelines included in Canvas. Be sure to review the rubric prior to submitting your finalized paper.

4) A research reflection paper will be due on February 10th. The paper will draw on your thoughtful analyses of a published, peer-reviewed journal article about addictions as well as your reflections on the relationship between the addiction behavior and development.

5) A course project will be due at the end of the course on March 5th. The cumulative project will require critical analyses of development and the project will be graded based on accuracy and clarity of your responses as well as appropriate grammar and spelling.
